Terms & Conditions

- Books, Uniforms , Transport & Medical Expenses are not included in the above.
- Breakages and damage to School property, willful or otherwise, is not included, and will be charged.
- The fee only includes basic medical expenses provided in-house like dressings and OTC type medicines for immediate relief. All medical expenses incurred outside the School towards Doctors, Hospitalisation, Medicines etc. will be borne by the Parent. For any medical emergency, the student will be taken to near by Hospital, while simultaneously informing the Parents.
- Rs 1000 will be charged for dishonoured cheques and the School will only accept online transfers/cash, thereafter.
- A Late Fee Fine of Rs. 50.00 per day shall be levied from the 11th day of each month, unless there is prior approval. Fee must be submitted **before 10th of the month**.
- The Tuition Fees shall be charged for 12 calendar months (April - March) in an Academic Session.
- The Tuition Fee is paid as per the School Fee structure and Parents will not receive any reminders for depositing the fee. Fees to be paid through School ERP(App) only
- 30 days written notice of withdrawal shall be given to The School Office**, failing which a month's fees will be charged. This applies to both Tuition Fees and Transport Fees & Fee will be charged for the Notice Period/Month
- If the outstanding fee exceeds 60 days, the student's name will be removed from the School Roll. Students wishing to continue studying at DGS would need to apply afresh.
- The school reserves the right to review the fees periodically and the same shall be applicable to all students.
- The Parent is expected to read and understand all the Policies of the School prior to taking Admission.
- All disputes shall be subject to competent courts having exclusive jurisdiction in district of Dehradun.
- The refund/adjustment/transfer of the fee once paid will be on a case to case basis depending upon School policy.
- Transport Charges are paid monthly and for 11 months/year. All amounts to be adjusted in the Tuition Fee first.
- Annual Event Charges of Rs 850 to be collected annually in August.
- School Magazine charges of Rs 500 to be collected annually in June.
- ID Card fee of Rs. 100 to be collected annually in April. Lost/Misplaced ID Cards will be replaced at a fee of Rs 100.
- CBSE Board/ registration fee is payable in the month of August/ September for Grade 9, 10, 11 & 12
- Alumni Member charge of Rs. 500 will be charged at the time of withdrawal. An administrative charge of RS. 50 will be charged for the TC at the time of withdrawal.
- All messaging is done on the School ERP App and Parents must download the same and understand it's working. Parents must also be comfortable using the internet, or having someone to assist them for this.
- For Grade 11 & 12 the fees include membership and participation in the NSS which is compulsory.
